The main text is written in Arial, size 10. The document is on A4 paper size in two columns.

The Header and Footer are different for odd and even pages, please insert the title of your paper in the "Paper Title" Header and the first author's last name in the "Author Name" Header, followed by et al.

## Figures, tables and equations

### Position

The figures and tables are placed on one of the two columns and are centered w.r.t. the column. They are referenced in the text by sequential numbering. If necessary, one-column (full page width) tables and images can be inserted with the format option "Wrap Text Top and Bottom".

## Citations and references

The references are listed in alphabetical order in the Harvard-Anglia style. They are written in Arial, size 9. The name of the journal/publisher/symposium etc. is written in italic. References in the main text are generally given between brackets and cited with the names of the authors (until three authors, all the authors are listed), followed by the publication year. Some useful commands:

- The command `\cite` does not use put brackets around references: Bailey, Mahlem, and Sang, 2010; Dibs and Rall, 2008.
- The command `\citep` is used to put the references between brackets: (Bailey, Mahlem, and Sang, 2010; Dibs and Rall, 2008).
- The command `\citet` puts brackets only around the publication year: Bailey, Mahlem, and Sang (2010) and Dibs and Rall (2008).
